### **RELEASE OF LIABILITY**

1. My crew and I recognize that sailing is an activity that has an inherent risk of damage and injury associated with it. We have read US Sailing's Racing Rules of Sailing, RRS 4 - Decision to Race, and hereby acknowledge and agree that we are participating in this event entirely at our own risk.
2. I acknowledge and agree that neither DCYRA, nor the race committee, nor their members, will be responsible for  
(a) any damage to the entered boat or any other property, or  
(b) any injury to myself or my crew, including death, sustained as a result of the participation of myself, my crew, and the boat in this event.
3. I hereby waive any rights I may have to sue DCYRA (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) with respect to personal injury or property damage suffered by myself or my crew because of our participation in this event and hereby release the race organizers from any liability for such injury or damage fully permitted by law.
4. I have taken all necessary steps to ensure that myself, my crew, and the entered boat are adequately prepared for all possible contingencies, including appropriate safety equipment as may be required by law or that a prudent seaman would consider advisable.
